The Vendor spaces are 20 feet by 20 feet. You must supply your own tables, tent, and chairs. Electricity is available if desired.

Sunday, September 18, 2022 10:00 a.m. - 5:00 p.m.

We encourage Not for Profit Vendors to provide an activity for those in attendance to enjoy while at the Worcester County Fair. You may use the activity as a fundraiser. The Fair will allow Not for Profit Vendors to promote and sell fundraising items or have raffles. **No food or drink items may be sold for fundraising.** 

- Booths must be set up during designated times.
- Vendors must release from any liability for injuries or losses associated with the Worcester County Fair, the Fair Board, the Town of Snow Hill, and its members and associates
- Vendors will only be permitted to have one vehicle parked at each booth. All others must be parked in designated Fair parking areas.
- Vendors are requested to be open during Friday Sunday during operating hours of the Fair.
- Security is provided Thursday Sunday by the Snow Hill Police Department.
